RE: Annual CUPCCAA Notification

To All Licensed Contractors:

The Foothill-De Anza Community College District has adopted the California Uniform Public Construction Cost Accounting Act (CUPCCAA) and its respective informal bidding procedures.

This notice is an invitation to all licensed Contractors to submit the name of their firm to the District via PlanetBids for inclusion in the District’s list of registered bidders for the 2025 calendar year as of January 1, 2025. The District utilizes PlanetBids as its e-procurement system, and for managing the list of registered bidders.

ACTION REQUIRED: PlanetBids Registration

NEW CONTRACTORS: To be included on the District’s List of CUPCCAA registered bidders for 2025, an interested Contractor must provide, at minimum (1) company name, address, and EIN; (2) contact name, email, and phone; and (3) CSLB license information on PlanetBids. When selecting the Commodity Codes that are applicable to the business, you must also include Commodity Code “900000 – Foothill De Anza Community College District CUPCCAA Registered Bidders.”

CURRENT REGISTERED CONTRACTORS: All licensed Contractors who are already registered with the District on PlanetBids must login to the Foothill De Anza Community College District Vendor Portal for PlanetBids to verify their company profile, contact information, CSLB license(s), and update if needed. To be included in the District's List of CUPCCAA Registered Bidders for the 2025 calendar year you must verify the Commodity Codes that are applicable

to your business AND you must also include Commodity Code “900000 – Foothill De Anza Community College District CUPCCAA Registered Bidders.”.

If you encounter any difficulties with registration, contact PlanetBids Vendor Support directly at 818-992-1771 and indicate you are registering for the Foothill-De Anza Community College District.

The registration process is for the purpose of 1) Adding your company to FHDA’s List of CUPCCAA Registered Bidders by selecting Commodity Code 900000, and 2) being notified of any future public works, repairs and maintenance bid opportunities that match your company profile and license classification. To submit a Bid, a Contractor must be properly licensed by the Contractors State License Board (CSLB) and must be registered with the state Department of Industrial Relations (DIR) at the time of submitting the bid.
